Both meetings get underway at 7:30 PM. The month of December is the only month in which the club has only one meeting. The first December meeting is reserved for the annual club Christmas party and no meeting is scheduled for the latter part of December due in part to the holiday season and the lack of member participation.

## BY LAWS MAJESTIC GLASS CORVETTE CLUB

### **Article I: Section I: Affiliation**

- (1) The official sponsor of MGCC shall be "Jerry Smith Chevrolet-Buick-Kia" of Anacortes, Washington.
- (2) Affiliation with the organization shall be entered into, so long as such affiliation is considered to be in the best interest of MGCC.

### **Article II: Section I: Meetings**

- (1) A regular business meeting shall be held twice monthly on the second and fourth Tuesday of each month beginning at 7:30 P.M.

### **Article III: Section I: Membership**

- (1) In order to obtain full membership privileges member(s): must own a Corvette.
- (2) Must have a valid motor vehicle operators license.
- (3) Must have automobile insurance that satisfies the requirement of the state of Washington.

### **Article III: Section II: Associate Membership**

- (1) Associate membership may be offered at the discretion of the club officers, after review of circumstances.
- (2) If associate membership is granted, dues will be \$20.00 per year and membership may be renewable upon review and approval of the club officers.
- (3) Associate members may participate in club functions but will not have voting privileges or be eligible to hold office. Upon qualification of requirements, full membership must be obtained.

### **Article III: Section III: Non Corvette Owners**

- (1) A MGCC member who disposes of their Corvette is entitled to regular membership privileges for the remainder of that fiscal year (June 1 - May 31) plus (1) additional year.

### **Article III: Section IV: Termination of Membership**

- (1) A member shall be terminated by a two-thirds vote of MGCC membership, initiated by any member who submits a motion at a regular business meeting.
- (2) The vote shall be by secret ballot.
- (3) Membership shall terminate for non payment of dues 30 days after due date.
- (4) Members who let their dues lapse may pay back dues to be reinstated to full and current membership status without losing their years of membership accumulation.

### **Article III: Section V : Dues**

- (1) Dues shall be \$25.00 per year. Payment of dues shall be the 1st meeting in June of each year. Associate member dues shall be \$20.00 per year.
- (2) New joining members paying dues other than the 1st June meeting will have their dues pro-rated by the month in which that member joined.

### **Article III: Section VI: Privileges**

- (1) The privileges of a member of MGCC shall include; the right to vote, to hold office, to attend and participate in all business meetings, competition events, social functions, promotional and fund raising activities.

- (2) The spouse/significant other of a regular member shall have the same rights and privileges within MGCC as that of a regular member.
- (3) A paid member may sponsor a guest(s), who otherwise qualifies for club membership, to attend any regular meeting and/or MGCC planned event (other than some selected events) at a maximum rate of 2 total prior to becoming a member.

**Article III: Section VII: Resignation**

- (1) A member may resign at any time, but there will be no refund of dues.
- (2) A member who resigns may, at a later date, submit a new application for membership. The membership application will be reviewed at a regular scheduled meeting and must receive a two thirds majority vote, by secret ballot, of members present to approve the application.

**Article IV: Section I: Officers**

- (1) There shall be four elected officers. They shall be President, Vice President, Secretary and Treasurer. Term of office shall be for one year.
- (2) It shall be the duty of each officer to attend all club meetings. If an officer is to miss three consecutive meetings, he or she may be asked to resign that particular elected office. The President shall appoint a new officer for the remaining term with the approval by a two-thirds majority of members present.

**Article IV: Section II: Duties of the President**

- (1) Overseeing and guiding MGCC business.
- (2) Conducting proper meeting procedures.
- (3) Keeping track of prospective members and their progress towards membership.
- (4) Presiding at all meetings and call special meetings.
- (5) In the event of a tied vote, the President may cast a deciding vote.
- (6) Maintain, or designate a member or Officer to maintain, a list of club property.

**Article IV: Section III: Duties of the Vice President**

- (1) To take the place of the President in his/her absence.
- (2) To assist the President in any manner delegated.
- (3) To assume the duties of the President, if the President shall resign or is otherwise incapacitated. To carry out the duties of his/her office until the President resumes his/her duties or until a new President is elected.

**Article IV: Section IV: Duties of the Secretary**

- (1) Take minutes at every regular meeting and special meetings.
- (2) Keep attendance records of club meetings and activities.
- (3) Maintain a current book of statutes which consist of all regulatory laws of MGCC.
- (4) Have custody of all papers belonging to MGCC which are not specifically under the charge of any other officer.
- (5) In the absence of the Secretary, a Secretary pro-tem shall be chosen by the presiding officer.

**Article IV: Section V: Duties of the Treasurer**

- (1) Collection of all money owed MGCC.
- (2) Paying from the treasury, all debts incurred by MGCC.
- (3) Keep records of MGCC monetary business.
- (4) Report on the financial status at each business meeting.
- (5) Report on the financial status at the end of the fiscal year.
- (6) All contracts, drafts, checks or other orders of payment of money shall be signed in the name of MGCC, by the President, Secretary or the Treasurer.

**Article IV: Section VI: Committee Chairperson**

- (1) The duty of each Committee Chairperson shall be to set up and control the committee required for the effective operation of MGCC.

**Article V: Section I: Election of Officers**

- (1) Annual elections shall be held during the fourth quarter of each year and in accordance with the Election Procedures.
- (2) Elected positions held by the same person, providing they are voted in, cannot exceed 3 consecutive, one-year terms.
- (3) At least two-thirds of the membership present shall vote for the Officers by secret ballot, and a majority of votes cast shall be received by a candidate in order that he/she can be elected.
- (4) Any member can be nominated to an elected position provided their dues are paid in full for the year the election is being held.
- (5) Officers who resign their positions, due to term limits, may hold other club positions, if so elected, and would then be limited to 3 consecutive, one-year terms in that new position.

**Article V: Section II: Election Procedures**

- (1) Annual election of officers will be held during the fourth quarter of each calendar year.
- (2) Nominations will be the first meeting in October. Nominee ballots will be included in the September newsletter. Nominee ballots will be dropped in the ballot box prior to first meeting in October. Names will be announced at the meeting.
- (3) The date and time for receipt of completed election ballots and the counting of ballots shall be the last meeting in November. The official announcement of new officers shall be at the annual Christmas party. The new officers shall assume their official duties at the first meeting in January after an appropriate ceremony which will include an oath of office and the reading of a code of ethics.
- (4) In all elections, voting shall be by secret and written ballot.
- (5) Separate mailing of ballots shall be supplied to each member, including spouse/significant other, in good standing (current dues paid) on the roster.
- (6) Ballots will be pre-printed, will include space for write-in candidates, and voting instructions with the deadline date clearly indicated.
- (7) A sealed ballot box will be available at the meeting site and all ballots, mailed or delivered in person, shall be secured in the ballot box until the deadline for ballot receipt has been reached. The ballot box will be monitored by a member of the election committee.
- (8) Lost ballots will not be replaced. Voting by proxy will not be permitted.
- (9) The election committee will be responsible for counting of ballots. If a member of the committee is running for office, he/she will be omitted from counting of ballots.
- (10) Counting of ballots will be private and supervised by a club member not running for office.
- (11) In case of a tie vote, a run-off election shall be conducted.
- (12) Election results will be immediately made to club officers for announcement to club members.

**Article VI: Section I: Business Transactions**

- (1) All officers must be present to transact any major money business.
- (2) The President has discretionary authority to spend up to \$200.00 per year in support of club business.

**Article VII: Section I: MGCC Newsletter**

- (1) A monthly newsletter shall be published, and shall give notice of all meetings and club activities.

**Article VIII: Section I: Voting**

- (1) All actions requiring a vote, except as noted in the By Laws, shall be by a majority vote.

**Article IX: Section I: Order of Business**

- (1) The rules contained in this Constitution and By Laws shall govern MGCC in all cases to which they are applicable.
- (2) In the event of the dissolution of MGCC, all money and/or property shall be donated to charities as determined by membership.

**Article X: Section I: General**

- (1) Members shall conduct themselves in a generally acceptable manner.
- (2) Members shall make an effort to keep up a good appearance in public.

**Article XI: Section I: Amending the By Laws**

- (1) Amending the By Laws may be submitted in writing at a regular meeting, and must be approved by two-thirds of the members present.
