Corvette found after carjacking at car wash

Victim says two men with guns robbed him of \$70,000 car

Even though the hour was getting late on Sunday night, Kirk Revelle thought nothing of taking his red 2012 Chevrolet Corvette to a midtown car wash.

He had been there before and found it to be an inexpensive place to clean his car -- costing only 25 cents to get the wash started.

He said he was in the area, having just picked up some medicine for his son at the Walgreen's at S.W. 10th and Topeka Boulevard. His next stop was to get his car washed, then to go to Walmart to purchase a floor mat for his car.

But things unraveled quickly when two young men came up to Revelle as he was washing his car with a suds brush.

"One of them asked me if I knew what time it was," Revelle said. "I went to check the time in my car, and the next thing I know, he had a shotgun pointed at me."

Revelle, of Meriden, didn't resist, and the pair made off with \$14 in cash and his \$70,000 Corvette around 10:30 p.m. Sunday at The Car Wash, near S.W. 10th and Mulvane.

As they were driving away, the young man in the passenger seat pointed a handgun at Revelle.

In a matter of moments, Revelle's car was gone and his life had just passed before his eyes.

"It still had soap suds on it when they drove away," Revelle said of his car. "I'm just glad to be alive."

Police responded to the scene and also began searching for the car in locations across Topeka.

As Revelle stood in the adjacent Burger King parking lot telling his story to police officers and family members around 11:15 p.m. Sunday, news came that his car had been located in the city's Highland Crest neighborhood.

Topeka police officer Kyle Jeanneret was on patrol in the city's Highland Crest area and spotted a vehicle in Betty Phillips Park, 3300 S.E. Irvingham.

Jeanneret said he drove up to the vehicle, and when he got closer saw it was an unoccupied red Corvette. There was little doubt in his mind that it was the stolen car.

Though the front console area had been damaged, Revelle would be able to drive it home early Monday, after the Topeka Police Department's Crime Scene Investigation Unit processed the vehicle.

Police officers ran a dog trail in the area of Betty Phillips Park and early Monday went to the Walmart store at 1301 S.W. 37th after a vehicle that was believed to have been possibly related to the carjacking was found in the parking lot.

However, police Lt. Scott Gilchrist said that as of 1:30 a.m. Monday, no arrests had been made.

Topeka police Sgt. Donna Ping said the suspects in the carjacking were described as black males, one of whom was about 5-6 and weighing around 150 pounds with short hair, khaki shorts and a white shirt. The other suspect was described as standing 5-10, weighing about 150 pounds, having dark skin and wearing a white tank top.
