The club will purchase a new brief case for Doug. Our new year's brunch will be at Bob's Burgers & Brew on January 1, 2016 at 1 PM.

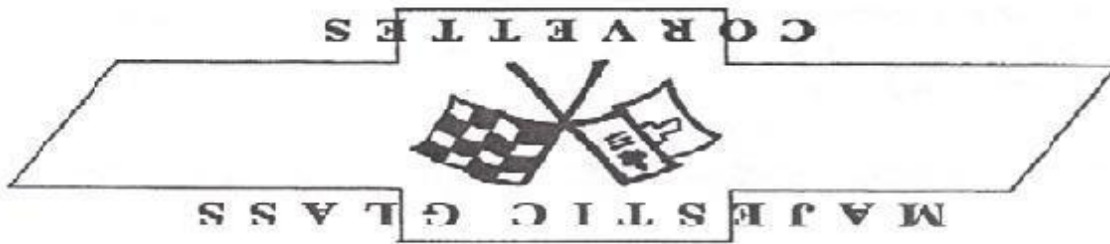
Meeting adjourned at 7:30 PM.
